

The Center for Youth Ministry Training respects the privacy of our donors and Web site visitors.

Thank you for visiting our Web site and reading the Center for Youth Ministry Training's Privacy Policy Statement. The Center for Youth Ministry Training exists to equip youth ministers and churches to develop theologically informed and practically effective youth ministries. We are a 501(c)(3) non-profit organization. Contributions are tax deductible to the extent allowed by law.

In order to fulfill its mission, the Center for Youth Ministry Training maintains databases that are compiled exclusively of information knowingly and voluntarily provided to the Center for Youth Ministry Training by our donors and Web site visitors. The Center for Youth Ministry Training respects the privacy of all donors and Web site visitors. The Center for Youth Ministry Training does not disclose, give, sell, or transfer any personal information about our donors and Web site visitors unless required for law enforcement or otherwise required by law.

Web users are justly concerned about what information is being collected, and how it is being used.

Privacy & Security for Donors

The Center for Youth Ministry Training respects and protects your privacy and will never sell, trade or rent your personal information to other individuals or companies. The information that you provide is used only to complete your donation. With your permission, your name and contact information will be published in the Center for Youth Ministry Training's Annual Report. If you do not wish to share your name and contact information you can make your donation anonymously. The Center for Youth Ministry Training provides a field to include an optional dedication with the donation.

Please note, the Center for Youth Ministry Training receives Memorial and Special Occasion donations both on-line and through the mail. The Center for Youth Ministry Training may list the name, city and state of the donor and the occasion in our newsletter, unless the donor requests otherwise. This is a well-established policy adopted by most charitable organizations. However, donor amounts and specific addresses are never disclosed. Donors who want the amount of their donation publicly disclosed may request the same from the Center for Youth Ministry Training.

We must disclose pertinent credit card information to appropriate banking institutions for those persons using credit cards to make donations to the Center for Youth Ministry Training. However, credit card information collected by the Center for Youth Ministry Training is used strictly for billing purposes.

Complying With the Legal System

Though the Center for Youth Ministry Training makes every effort to preserve donor and customer privacy, we may need to disclose personal information when we have a good-faith belief that such action is necessary to comply with a current judicial proceeding, a court order or legal process served on our organization.

Changes to the Policy

The Center for Youth Ministry Training periodically reviews and updates this privacy policy. If we decide to change our privacy policy, we will post those changes to our web site so our donors and customers are always aware of what information we collect, how we use it, and under what circumstances, if any, we disclose it.

Site Visitorship Data

The Center for Youth Ministry Training routinely gathers data on Web site activity, such as how many people visit our Web site, the pages they visit and where they come from.

Site visitorship data is collected on an aggregate, anonymous basis, which means no personal information is associated with this data.

Please be aware that our Web site contains links to other Web sites and that the privacy practices of these other Web sites may differ from those of the Center for Youth Ministry Training. Each Web site is responsible for its own privacy practices.
